## **OBJECTIVES:**

Provide a new avenue of expertise that addresses current childcare advocacy initiatives while opening a broader career opportunity:

## THE EDUCATIONAL LEARNING EXPERIENCE:

- 1. Provides an informative learning base from which a registered Professional Certified Pediatric Technician can evaluate and advocate for the special needs child.
- 2. Provides the knowledge necessary to coordinate services, outreach programs and support for families, educational services, and legal professionals (with emphasis on the challenged child).
- 3. Provide class participants with rewarding growth opportunities in a multi-dimensional career path.
- 4. Provide additional knowledgeable staff that can apply their academic knowledge and experience to enhance a professional firm.

## PROTECTIVE SERVICES:

- Provide case managers, master social workers, attorneys and life planners with a liaison for children and families.
- Equip Para-professionals with the ability to recognize, properly observe and assess, document and advocate for the whole child.
- Supply skilled advocates who have been educated to contribute to the inclusion of disabled and challenged children, especially those in Foster Care and Protective Care.

#### **COST BENEFITS:**

- Reduce the cost of exposure to lawsuits by providing intermediaries who can promote quality standards and procedures.
- Reduce the cost of insurance because credentialed and certified advocates with defined goals can ensure and promote quality care, especially for special needs children who require advanced support.
- 3. Support families with Professional Certified Pediatric Technicians who can understand and develop care plans approved by a supervising authority in various settings.
- 4. Employ "Job ready personnel" to staff a facility or office or firm.

- Have parents in need of professional support.

- To identify the goals and realize the successful outcomes of the disabled child.
- To acknowledge the direct link between physical health, education, social services and legal representation and the rights of the child.
